### What SBI does not maintain...

- Civil violations
- Warrants
- Protection orders
- BMV (Title 29-A)misdemeanors & offenses <u>not</u> involving drugs or alcohol (ex. Traffic infractions speeding tickets, failure to stop at light/sign, etc...)
- IF&W (Title 12) misdemeanors & offenses <u>not</u> involving drugs or alcohol

#### What is on Maine criminal history...

- Conviction/adjudication only information....
  - Pending charges (within one year) if SBI has received prosecutor information
  - Dismissed by DA Pled Other Charge
- Any offense that by statute is labeled "criminal"
- Any Title 12 or 29-A offense <u>involving drugs or alcohol</u> after 09/01/00
- Any <u>felony</u> Title 12 or 29-A offense after 09/01/00
- Any <u>felony</u> level juvenile adjudication with offense after 09/01/00

- Charges are listed with description of offense, statute and class if provided (and severity - misdemeanor or felony)

#### prosecutor information

- The Prosecution date and agency name listed
- The cycle tracking and charge number still follow into the pros segment
- Charges are listed with description of offense, statute and whether misdemeanor or felony
- The "Prosecutor Action" is what the DA office decided to do with the charge
  - Filed or added means it's going to court
